Under Section 4(2) of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement, Act 2013.

WHEREAS, acquisition of land area measuring 1.2693 Acres/5137.07 Sq. Meters at Mawpdang village, East Khasi Hills District for the purpose of setting up of Receiving Terminal (RT) Station for North East Gas Grid Project construct/ develop by Indradhanush Gas Grid Limited (IGGL) is/are proposed.

WHEREAS, a Social Impact Assessment team of the Meghalaya Institute of Governance (MIG) has been formed to consult, to survey and to take public hearing after publication of this Notification.

WHEREAS, the foresaid team will fix and indicate the date and venue for which all concerned will be requested to remain present with their claims/objection/suggestion, if any.

WHEREAS, the concerned land owner, Dorbar shnong Mawpdang, Headman and villagers may remain present for hearing for consent/ approval for the project.

WHEREAS, the process must be completed and SIA report must be submitted along with the plan (SIMP) within the time specified as per RFCT-LARR Act, 2013

WHEREAS, any attempt at coercion or thread against the process during the specified period will render the exercise null7 VOID.


